## July 1, 2024 President's Report

- 6/14/2024 DDA Meeting Approved the Village's purchase of Perennials for the flower boxes in the DDA District. Flowers purchased at White Barn Gardens on M-72 in Harrisville, with the advice of Billi Thompson. Marsha coordinated the purchase and planting.
  - Mr. James is helped the Village with the installation of the new concrete blocks down at the beach area. Each block can stop up to 3500 pounds. This will provide a safer barrier for the public beach. The blocks are set, and they look real nice. Staff will be removing the old posts.
- 6/18/2024 Planning Commission Meeting discussion was held with regards to NEMCOG's proposal to updating the Village Master Plan, Parks and Recreation Plan and Zoning Ordinance. The Commission referred it to the Village Council for Consideration at the July 1,2024 meeting.

Discussion was held with regards to allowing Marijuana retail shops within the Village Limits. Marilyn Wissmiller shared with the Commission the information that she gathered.
